#### A. PRE-BID RFI QUESTIONS AND RESPONSES

 QUESTION: Please clarify if the split systems are to come with their own factory controls/thermostat and BACnet interface or if a Johnson Controls PCG controller/stat/sensors are required for unit control. EMS detail on M5.1 shows PCG control panel. Everywhere else has reference to factory controls and BACnet interface.

**ANSWER:** Split-system equipment shall be provided with factory thermostat and BACnet MSTP interface. Contractor shall integrate the split-systems into the existing FX80 controller located in the MPR mechanical room. License expansion of the existing FX80 controller is required as part of the project bid to accommodate the additional devices for a complete and operable system.

QUESTION: Will the refrigerant lines be run across the top of the roof and then drop down to the fan coils? If so, is there a detail we need to follow for supporting the refrigerant lines?

**ANSWER:** Refrigerant piping shall be installed on the roof from the condensing unit to the drop downs through roof to the respective fan coil unit. Refer to detail #8, sheet M4.2 of DSA addendum #1 dated October 20, 2020. All roof mounted refrigerant piping shall be insulated per specifications and encapsulated with continuous aluminum jacket.

3. **QUESTION**: On sheet E4.1, detail 2 keynote 1, it states that we are not to connect to the high leg terminal when doing the feeder to Panel AC2A. We believe that this note does not belong on the drawing. Please verify.

ANSWER: Contractor to disregard note. Note not required on plans.

4. **QUESTION**: On sheet E3.3, general note 3, it states that the contractor is to coordinate with the District regarding needed changes to reporting zones. Please clarify the scope of work associated with this.

**ANSWER:** Contractor to provide one (1) relay per reporting zone. During construction, contractor to schedule a site meeting with District Maintenance Electronic Shop for coordination and programming requirements. Refer to sheet E3.3 of DSA Addendum #1 dated October 20, 2020.
