- Q1. In regard to the RFQ for Investigative Services, are you able to disclose what your budget is for this, or what your annual spending was for this prior contract?
- A1. For the 2018-19 fiscal year, Fresno Unified School District incurred approximately \$280,764 in investigation/adjuster expenses for all services incorporated in RFQ 20-35. This RFQ process is for prequalification only and does not commit the District to engage the organization for services.
- Q2. Do you currently have a list of approved and/or previously awarded vendors for these services? If so, may I see it?
- A2. Investigation/adjuster services are currently provided by the following individuals/firms; Davison & Associates, Rene Garza & Associates, Haroldsen Investigative Services, Shawn Patty Investigations, Oliver, Thomas & Pierce Investigations/Adjusters, Nation & Badilla Investigations and Leist & Associates.
- Q3. What are the current prices you pay for these services? (hourly and/or per investigation)
- A3. Current hourly rates for investigative/adjusting services range from \$65-\$105/Hour depending on the nature and complexity of assignment(s).
- Q4. How many investigations do you anticipate annually? What have been the previous rates established between prior Firms and the County for similar services?
- A4. Page 10 of the RFQ provides the approximate number of general liability investigations assigned between July 1, 2017 and October 2019. See the response to question 3 above for rates.
