Responses shall be sealed, prominently marked with the BID Number, BID title, BID opening time/date and name of company. BID pricing will be read out loud since award following receipt of BIDS. BIDS received later than the designated time and date will not be accepted. Facsimile (FAX) or e-mailed copies of submittals will not be accepted.

Award of this Bid will be to the lowest responsive, responsible bidder with the lowest "accumulated price" and pass all the Evaluation Criteria set forth in the BID, Article 7 B of Special Instructions and Conditions.
