**TITLE AND SUBJECT: Approve Award of Bid 20-58, Dry and Frozen Food Products**

**ITEM DESCRIPTION:** Included in the Board binders is information on Bid 20-58, to establish fixed pricing on meal ingredients and menu items for delivery to the Nutrition Center for the National School Lunch Program, School Breakfast Program and Child and Adult Care Food Program. All items in the bid meet meal pattern and nutritional requirements. Menus for student meals are carefully developed to meet or exceed the requirements while considering student palates, variety, and cost.

Submittals were evaluated on pass/fail criteria for food safety, delivery, on-line ordering, and alignment with good food purchasing program standards. The agreements are for one year with two one-year renewal options. The request for bids was lawfully advertised on April 30, 2020 and May 7, 2020. The bids were opened on May 28, 2020. Notifications were sent to 124 vendors, and the district received 11 responses. Staff recommends award to the lowest responsive, responsible bidders by line item:

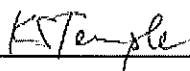

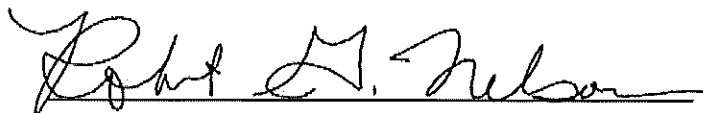
