The following track surfacing products are approved as equal to currently specified system. All requirements currently specified shall follow Order of Precedence provisions listed in Information to Bidders."



NOTES:

- 1. REMOVE EXISTING CONCRETE & ASPHALT AS NECESSARY FOR NEW CHUTE AREA IMPROVEMENTS.
- 2. CAP IRRIGATION OUTSIDE OF NEW CHUTE FOOTPRINT. REESTABLISHING IRRIGATION BY DISTRICT.
- 3. REMOVE AND STOCKPILE EXISTING AGGREGATE BASE. SCARIFY AND COMPACT SUBGRADE TO 95%. SET STOCKPILED AGG BASE AND COMPACT TO 95%
- 4. TACK COAT ALL SURFACE EDGES PRIOR TO PLACEMENT OF NEW ASPHALT.
- 5. LISTED DIMENSIONS AND ELEVATIONS ARE FOR INFORMATIONAL PURPOSES ONLY. CONTRACTOR RESPONSIBLE FOR VERIFYING EXISTING ELEVATIONS & DIMENSIONS.
